

# **Qualification Overview**

The Ascentis Level 1 Award in Understanding Safeguarding for Work, Education and Life is designed to give learners knowledge and understanding of safeguarding in work, education and life contexts. This includes the different types of abuse and how to recognise them, possible safeguarding issues caused by modern technology, the meaning of discrimination and victimisation and the importance of disclosing safeguarding concerns to professionals.

There are several features of this qualification that make it very appropriate for its target learners:

- Assessment and certification can be offered throughout the year, allowing maximum flexibility for centres
- It can be delivered either as a classroom-based course or as a blended learning programme
- Assessments are primarily offered through an online multiple-choice test that will normally be taken at the end of the course.
- There are online resources that can be used alongside the teaching

#### **Aims**

The aims of the qualification enable learners to:

- 1 Know the meaning of safeguarding in work, education and life contexts
- 2 Know different types of abuse and their recognition features
- 3 Understand the possible safeguarding issues caused by modern technology
- 4 Understand the meaning of discrimination and victimisation
- 5 Understand the importance of disclosing safeguarding concerns to professionals

- Young people wishing to pick up an Award as part of another learning programme
- Young people aged 14 19 who are in various learning environments
- Adult learners
